

## **CSSCLOUD is committed to protecting and respecting your privacy.**

We regularly update this Privacy Notice to ensure that You are always accurately informed about how we collect, hold and manage Your Personal Information. Please read this Privacy Notice together with our Terms of Use and any other documents referred to in it to help you make informed decisions about providing CSSCLOUD with your Personal Information.

Whenever you provide Personal Information, we are legally obliged to use it in accordance with the laws concerning the protection of Personal Information.

### **WHO WE ARE**

**CSSCLOUD is a specialist IT support and service provider. This Privacy Notice applies to anyone whose Personal Information we collect and use in the course of our business.**

**CSSCLOUD LIMITED** is a company incorporated and registered in England and Wales with company number 10773055 whose registered office is at Nimbus House Marine Park, Gapton Hall Road, Great Yarmouth, Norfolk, England, NR31 0NB ("**CSSCloud**")

For the purposes of the General Data Protection Regulations and any other applicable data protection and privacy laws and regulations ("**Data Protection Legislation**"), CSSCloud will be the 'Data Controller' for all Personal Information we determine the means and purpose of processing.

Our registration with the ICO under reference **ZA364937** and all of our data protection practices are aimed at ensuring we provide all of the protection required under Data Protection Legislation to Your Personal Information. This Privacy Notice is designed to inform you how we do that in a clear and concise fashion. If you have any questions about our data handling practices, please contact us at the address below.

By "**Personal Information**" we refer to data collected or held by CSSCloud, that identifies and relates to you as an individual.

### **INFORMATION WE MAY COLLECT**

We may collect Personal Information about you in the following circumstances to enable us to provide you with the services we offer.

We collect Personal Information when you request services from CSSCloud, typically including:

- Your name;
- Postal address;
- Invoicing details/address;
- Information regarding the services you request;
- Supplementary information you provide us about yourself when contacting us;
- Email address;
- Telephone numbers (including mobile).

We may also collect technical information about you when you visit the Website. This information may include the Internet protocol (IP) address used to connect your computer to the Internet, your browser type and version, time zone setting, operating system and platform, browser plug-in types and version, the full URL clickstream to, through and from the Website, page response times, download errors, length of visits to certain pages, page interaction (such as scrolling, clicks and mouse-overs) and methods used to browse away from the page.

The collected information is used to provide an overview of how people are accessing and using the Website.

We may also receive details about you from third parties who have provided us with your information under an appropriate legal grounds for sharing. We will always inform you of how we received your information when we contact you.

## IF YOU FAIL TO PROVIDE US WITH PERSONAL INFORMATION

You always reserve the right to withhold your personal information but this may affect how we provide our services

Where we need to collect personal data by law, or under the terms of a contract we have with you and you fail to provide that data when requested, we may not be able to perform the contract we have or are trying to enter into with you. In this case, we may have to cancel a product or service you have with us but we will notify you if this is the case at the time.

## WHAT WE DO WITH THE INFORMATION WE COLLECT

We will only ever use your personal information when allowed to by law and always under a documented lawful basis for processing

We will use your Personal Information for a number of purposes including:

- to process the services you request;
- to ensure our records are complete and accurate;
- to provide the specific services agreed by you;
- to undertake sales analysis and management of the business;
- to give you information that you request from us and to improve our services;
- to notify you about changes to our services;
- to allow us to operate the Website efficiently;
- any relevant troubleshooting, testing or statistical analysis as appropriate; and
- to keep the Website secure.

Where we have your permission to do so, we may also use the information collected to:

- provide you with information about our services that we offer via promotional communications;
- keep you up to date with features on the Website.

However, you can opt-out of any of these data uses at any time by emailing [info@csscloud.co.uk](mailto:info@csscloud.co.uk). We will only keep your information for as long as reasonably required or as stated in the contract you have with us.

## LAWFUL BASIS OF PROCESSING

We always ensure that a Lawful basis exists for all of the Personal Information we process at CSSCloud.

We will only process your information for as long as we have a relevant lawful basis to do so. This is usually in order to provide you with the contractual services you have requested from CSSCloud or if you have provided us with adequate consent to process your information for other purposes.

If we choose to process your information under the lawful basis of legitimate interests, we will always inform you of our legitimate business interest and your right to object.

If you choose to access your Personal Information under the rights afforded to you by Data Protection legislation, we will always inform you of the lawful basis under which we process your information.

## DATA RETENTION

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

To determine the appropriate retention period for personal data, we consider the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorised use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve those purposes through other means, and the applicable legal requirements

## PROTECTING YOUR INFORMATION

We take our security obligations very seriously and constantly monitor for breaches and potential weaknesses.

We are committed to ensuring that your information is secure and we have procedures in place to try and prevent any unauthorised access or disclosures and to safeguard and keep secure the information that we collect online.

All the Personal Information collected by us and stored electronically is held on a secure server in the EEA only. Where required, this information is encrypted for additional security. We use computer safeguards such as firewalls and data encryption, we enforce physical access controls to our buildings and files, and we authorise access to Personal Information only for those employees who require it to fulfil their job responsibilities.

However, you should be aware that providing information over the internet can never be guaranteed as being completely safe and if you choose to send such information to us via the internet, you do so at your own risk.

## DATA PROTECTION OFFICER

CSSCloud appoints a Data Protection Officer to oversee Data Protection across the whole company. ## TRANSFER OF DATA OUTSIDE OF THE EU

If we are required to store or process your data outside of the European Economic Area

We shall not transfer any Personal Information to any country outside of the European Economic Area unless we ensure that such Personal Information is subject to an adequate level of protection and appropriate legal safeguards in accordance with Data Protection Legislation. If you wish to access your Personal Information, we will inform you of the transfers we make (if any) and the legal safeguards we have employed to ensure the ongoing security and protection of your data.

## SHARING YOUR INFORMATION WITH OTHERS

If and when we share your data, we always do so under a written agreement governing how your data must be protected

Please be assured that we will not share your information for any other reason unless we are required by law or permitted to do so under this Privacy Policy. The main circumstances in which we will be permitted or required to disclose this is by law will be by court order, to government bodies and law enforcement agencies. However, sometimes we may share your information with third parties in the following ways:

- we may use carefully selected sub-processors to help us collect, store or manage your information. This will always be managed under the terms of a written data processing agreement.
- analytics and search engine providers that assist us in the improvement and optimisation of the Website; and
- if CSSCloud is acquired by a third party, in which case Personal Information held by it about its customers will be one of the transferred assets. We process your Personal Information for this purpose because we have a legitimate interest to ensure our business can be continued by the buyer. If you object to our use of your Personal Information in this way, the relevant seller or buyer of our business may not be able to provide services to you.

## ACCESS TO YOUR PERSONAL INFORMATION

Our obligations under Data protection Law and your options to control your Personal Information

You have rights in relation to any Personal Information that we hold about you. If you wish to access your Personal Information you may make a formal subject access request by contacting CSSCloud.

The information you request must relate to you or another person that you have authority to act on their behalf. CSSCloud will require a confirmation of your ID prior to providing any information about the data we hold. If you are unable to provide sufficient information to prove your ID, CSSCloud reserves the right to refuse your request for access to Personal Information.

The rights you have in relation to the Personal Information we hold regarding you are:

- the right to rectify any inaccuracies in the information we hold;
- the right to erasure of information in specific circumstances;
- the right to request transfer of your information to another controller; and
- the right to object to processing in specified circumstances.
